OFFICIAL RULES

The Station will conduct the 999 The Hawk Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY. Eligibility. At approximately 12:00pmET on Thursday, August 29:2024, listeners will receive a text from 99.9 The Hawk with instructions to reply to the text with a secret keyword. Everyone who applies will be automatically entered. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Only one (1) entry per person per phone number per giveaway will count as a submission for the duration of the contest period. Multiple daily texts will be accepted but will not increase your odds of winning. Multiple participants are not permitted to share the same telephone number. - (ii) Online: Email your first and last name, date of birth, address, and phone number to contest@999thehawk.com for automatic entry. All entries must be received by 2:00 pm ET on August 29, 2024 to be eligible for the grand prize drawing. Limit one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will 2 void that entry and the participant may be disqualified.
